Corrigendum No.3

In the Notice Inviting Bid No14974 dated 28.12.2020 and published in News Papers on 01.01.2021 for Supply of Indian CTC Tea and Refined Iodised Free Flow Salt at Authorised Dealers due to Gazette Notification issued by Finance (G&T) Department on 18.12.2020 the amendment made in Rule 42 of Rajasthan Transparency Act, 2012 (Act No.21 of 2012) Rules 2013 and Circular issued on 23.12.2020 regarding "in lieu of Bid Security Bid Declaration, may be taken' the Clause No. 32 of Tender of CTC Tea and Refined Iodised Salt is amended/modified to the extent notified below:-


The existing proviso to sub rule (2) of Rule 42 of the Rajasthan Transparency in Public Procurement Rules, 2013 hereinafter referred to as the said rules, shall be substituted by the following namely:-

"Provided that, during period commencing from the date of commencement of the Rajasthan Transparency in Public Procurement (Second Amendment) Rules 2020 to 31.12.2021, in lieu of bid security a Bid Security declaration shall be taken".

"चूंकि उक्त नियमों में बिड सिक्यूरिटी राशि के स्थान पर बिड सिक्यूरिटी के संबंध में घोषणा पत्र (declaration) प्राप्त करने का नवीन प्रावधान किया गया है। अतः समस्त उपापन संस्थाओं के उपयोगार्थ बिड सिक्यूरिटी के संबंध में लिए जाने वाले घोषणा पत्र (declaration) का मानक प्रारूप संलग्न प्रेषित है। राजस्थान स्टाम्प अधिनियम, 1998 की धारा 3 सपठित अनुसूची के अनुच्छेद 4 के अनुसार घोषणा पत्र(declaration) पर 50/- रुपये स्टाम्प ड्यूटी देय है तथा इस स्टाम्प ड्यूटी की राशि पर नियमानुसार 30 प्रतिशत सरचार्ज देय है।"

**Now in place of Bid Security as mentioned in clause No. 32 of Tender Document of Indian CTC Tea and Refined Iodised Free Flow Salt only Bid Security Declaration is to be submitted by all the firms participating in the Bid on Stamp Paper of Rs. 50/- and as per Rajasthan Stamp Act, 1998 clause 3 read with Article 4 of Schedule Declaration letter is to be submitted on which Rs. 50/- Stamp Duty is Payable and on this Stamp Duty 30% Surcharge is payable. The Bid Declaration form is enclosed for reference.

We, the undersigned, declare that:

We understand that, according to your conditions, bids must be supported by a Bid-Securing Declaration.

We accept that we are required to pay the bid security amount specified in the Term and Condition of Bid, in the following cases, namely:-

- (a) when we withdraw or modify our bid after opening of bids;
- (b) when we do not execute the agreement, if any, after placement of supply/work order within the specified period;
- (c) when we fail to commence the supply of the goods or service or execute work as per supply/work order within the time specified;
- (d) when we do not deposit the performance security within specified period after the supply/work order is placed; and
- (e) if we breach any provision of code of integrity prescribed for bidding specified in the Act and Chapter VI of these rules.

In addition to above, the State Government shall debar us from participating in any procurement process undertaken for a period not exceeding three years in case where the entire bid security or any part thereof is required to be forfeited by procuring entity.

We understand this Bid Securing Declaration shall expire if:-

- (I) we are not the successful Bidder;
- (ii) the execution of agreement for procurement and performance security is furnished by us in case we are successful bidder;
- (iii) thirty days after the expiration of our Bid.
- (iv) the cancellation of the procurement process; or
- (v) the withdrawal of bid prior to the deadline for presenting bids, unless the bidding documents stipulate that no such withdrawal is permitted.
