**Corrigendum No.1**

In the Notice Inviting Bid No14974 dated 28.12.2020 for Supply of Indian CTC Tea at Authorised Dealers following clauses of the tender document are amended/modified to the extent notified below:

- 1. E-Bid Notice – (Page No. 16)- Condition No. 38 Duration and Place of Delivery may be read as:** The bidder will get the demand through software from the Corporation and will accordingly arrange the supply at the concerned AUTHORISED DEALER. The bidder shall have to compulsorily supply ordered quantity of CTC Tea as per specifications prescribed within 30 days of receipt of order from the Corporation at specified AUTHORISED DEALER destinations as per Annexure-'J'. Time taken for design approved and receipt of hologram is included in 30 days i.e. extra time will not be given. The bidder shall have to get design approved & issuing of hologram within three working days from the date of execution of agreement. Request for extra time for this purpose will not be given.

The Exclusive Privilege Amount (EPA +GST as applicable) + amount which come in rounding off the MRP will be deducted by the corporation on the basis of actual supply at AUTHORISED DEALER of allotted districts/area.

- 2. E-Bid Notice – (Page No. 17-18) Condition No. 42 Exclusive Privilege Amount to Corporation:** The concerned AUTHORISED DEALER will have to deposit the amount in advance after deducting 10% Commission with the order placed of tea to the RSFCSC through software. The bidders will raise the monthly Bill at approved rates to the corporation of the supplies made to Authorised Dealers along with copy of Challan. The Corporation after deducting 3% EPA (Exclusive Privilege Amount) + GST (if applicable) on the actual supplies made + amount which comes in calculation of rounding off the MRP will release the payment to the Bidder every month online.

The Supplier(s) would avail exclusive privilege of AUTHORISED DEALER network for marketing "RAJ" brand of CTC Tea hence, they shall pay actual Exclusive Privilege Amount (EPA) @ 3% + GST as applicable +amount which comes in calculation of rounding off the MRP of item on actual CTC Tea supplied.

**Illustrative example of calculation of EPA:** The EPA (Exclusive Privilege Amount) + GST on EPA will be deducted directly from the bill of the bidder on actual supply of CTC Tea @ 3% +GST as applicable +amount which comes in calculation of rounding off the MRP of item.

- 3. Till the Software is developed all the work will be carried out manually.**
