Pre Bid queries were called on 27.11.2017 for EOI to develop (सिस्टम) and maintain a mobile phone based monitoring and evaluation application software for Raj-Brand Non PDS Items. The Committee of the following Officials were present in the pre bid queries:-

1. General Manager (Administration)
2. General Manager (Finance)
3. General Manager (Marketing)

In the pre bid query Sh. Rajeev Ranjan representative of Krish Compusoft Services P. Ltd, Ahmedabad Gujrat was also present and has suggested the following modifications:-

- A. **Introduction:** - Only 7 products is given in the list. If no of products to be added in future of list of the product will be added in future is specified then it would help in costing.
- B. **Scope of Work:-** The details of scope of work is not very clear.
- C. **Eligibility Criteria:-** If any of the vendor has already developed same kind of application for Rajasthan Govt. then the vendor will get preference in selection process.
- D. **Eligibility Criteria:-** Is there some criteria to fulfill this clause.
- E. **Terms of Reference:-** The technical evaluation of vendor will be based on the annexure-1 and as eligibility criteria or some other method.
- F. Interfacing/Integrating with any particular system or there are different system existence?
- G. The application should be on Native or Cross Platform.

1. Whether back end web application is built through which mobile application will communicate and get the commodities details for order and recorder?
2. If the web application already exists then whether web services are exposed and accept request and provide response in JSON/XML format.
3. Whether Fair Price Shops are already registered.
4. What features/functionally are to be provided to the supplier?
5. Whether Mobile App will be created for supplier or only for FPS?
6. Whether order from FPS will directly be available to suppliers/particular suppliers or RSFCSC will raise order to supplier after consolidation of all orders from FPS?
7. Scope of Work Point No. 6. Page No. 3:- Kindly describe which type of task would fall under (Any other related task(s)).

On Dated 27.11.2017 another query has been received from Sh. Jaiveer Singh, Enuke Software Pvt. Ltd.:-

1. Please explain the payment schedule to the successful bidder.
2. Does the successful bidder has to submit some performance guarantee or bank guarantee?
3. Who is responsible for the ownership of the application account on Google Play Store and iTunes to launch the application?

The Committee discussed on each query and it was decided that:-

1. At present Raj. Govt. has decided only 7 products of Non PDS items if they are increased and added in future than the same will be informed to vendor and any up gradation or alteration/solution should be made available by the firm.
2. The Weekly, Monthly and Yearly report can be taken by any concerned at any *time*.
3. The rating is also compulsory so that it can be ascertained that the App is working properly. The message of

transaction and process between two persons should go the Admin.

4. The L 1 will be decided by the Corporation on its own discretion as per requirement.
5. If Committee after scrutinising the Technical Documents and Eligibility Criteria of any Vendor is satisfied than the financial bid of that Vendor will be opened.
6. Any person can download the App from play store on mobile and can take the information but the access should be at four levels only.
7. The access can be done on only android or i phones but not without downloading.

At present no Mobile App and Web App has been built and no Web App is in existence but the Corporation wants to built it now for order and reorder - *supply monitoring purpose.*
